### A Point of Personal Privilege

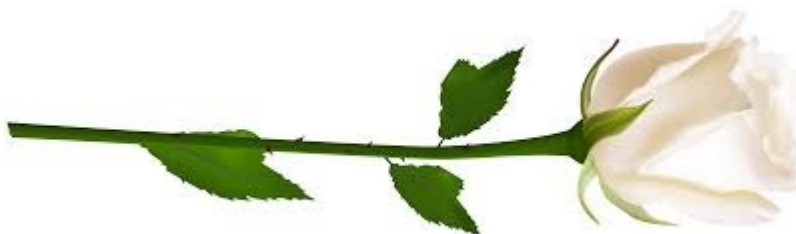
February is the month of love and of the celebration of Black History. Throughout history we have survived and thrived due to strong Black women.

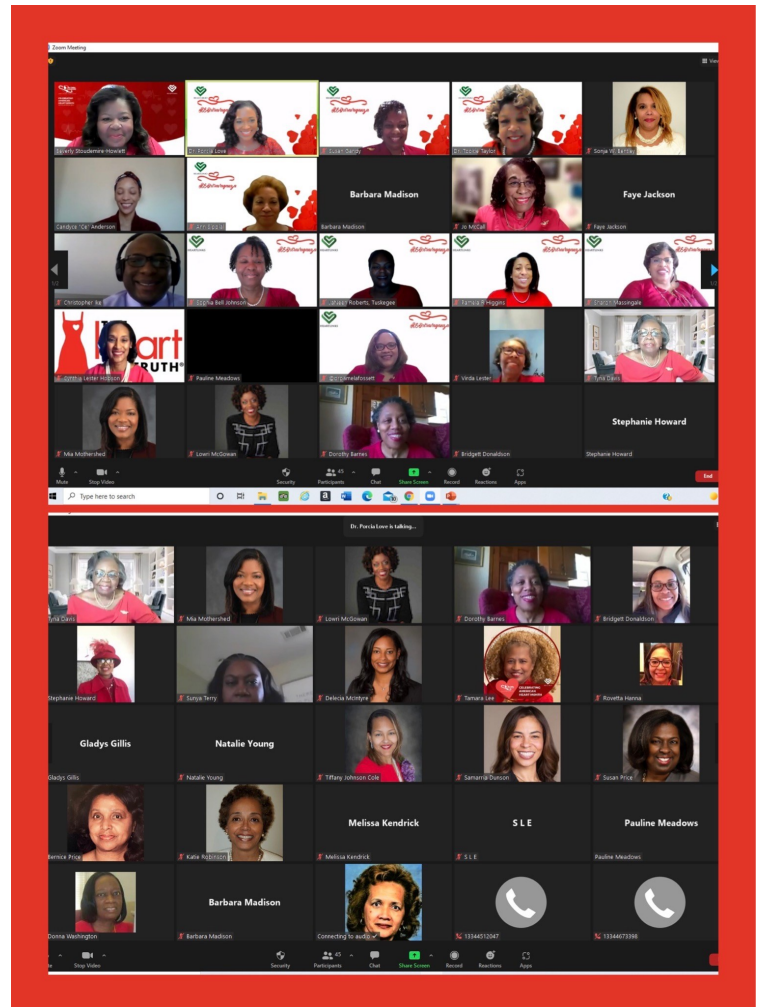


## Protocol Pearl

# Parliamentary Tip for February

## Can an “abstention vote” affect the outcome of a vote?

The definitive answer is “well, maybe.”

First things first: *to abstain* means to refrain from voting, so there is no such thing as an “abstention vote.”

Typically, an abstention has no bearing on the outcome of a vote where the rules simply require a majority or other percentage vote in the affirmative. However, if the rules explicitly require a majority or other percentage vote in the affirmative *of the members present* or *of the entire membership*, then an abstention has the same effect as a “no” vote. Even in that case, an abstention is not counted as a vote and is not recorded as a vote.

The key to understanding the impact of an abstention often lies in the wording that describes the required vote.

### Example 1:

Chapter bylaws require a matter be decided by a majority vote **of the active members present**. 30 active members are present when the vote is taken. 15 vote in favor of the motion, 14 vote against the motion, and one member abstains from voting. The motion fails because the number of active members present is 30. A majority of that number is 16. In this case, the abstention affected the outcome of the vote.

### Example 2:

Chapter bylaws require that a matter be decided by a majority **of the active members present and voting**. 30 active members are present when the vote is taken. 15 vote in favor of the motion, 14 vote against the motion, and one person abstains from voting. The motion passes because the number of active members present and voting is 29. A majority of that number is 15. In this case, the abstention did not affect the outcome of the vote.

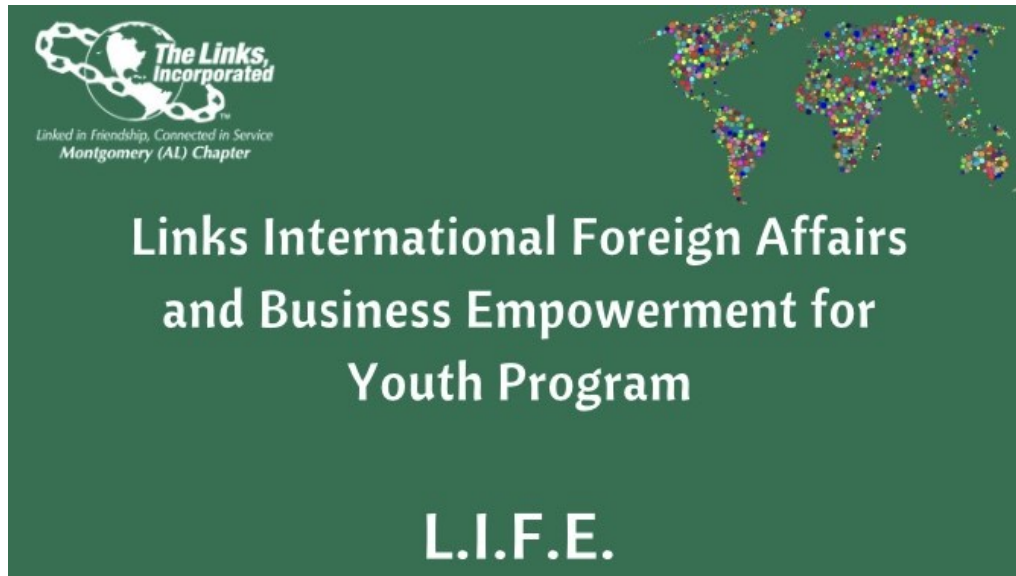

## *International Trends*

The International Trends and Services (ITS) Facet collaborated with the Services to Youth (STY) Facet to launch the *Links International Foreign Affairs and Business Empowerment for Youth (LIFE) Program* on Saturday, February 5, 2022. Alabama State University Upward Bound students participated in a virtual LIFE Program Overview. This program exposes minority high school students to career possibilities in foreign affairs and international business. The students were very enthused by the information and incentives that were shared.



## *S.T.E.A.M Academy*

The STEAM Academy is an integrated program designed to cultivate interest in STEAM majors and careers. The program provides exploratory and field experiences in science, technology, engineering, arts, and mathematics for middle school and high school youth. (This population includes students in grades six through twelve). A collaborative team comprised of leadership from four facets and two program coordinators is responsible for service delivery of the STEAM Academy. The five facets responsible for program services are: The Arts, Services to Youth, National Trends and Services, International Trends, and Health and Human Services. The STEAM Academy Curriculum is also complemented with a focus on leadership skills that is executed through the infrastructure of the NSBE (National Society of Black Engineers) Jr. Club and the Alabama State University Upward Bound program.

On February 5, 2022 Service to Youth partnered with the International Trends and Services to introduce the LIFE program. Link Pamela Fossett led the students in an informative session that included the purpose of the program and an exciting description of the upcoming modules. Over the next three months members of the Montgomery chapter along with special subject matter experts will present workshops on “Whole New World”, an introduction to foreign services, Cash Rules Everything Around Me and the World (CREAM), and “Steam in Action”.

At the conclusion of the presentation students shared their thoughts and excitement about upcoming events. Three students were awarded prizes from Link Josephine McCall for extraordinary participation in the seminar.
